The National Society of Master Thatchers is the country's leading group of thatchers and represent about one third of the thatchers in Britain. Our members get support from a team of experts who are working to keep them informed of important changes to regulation. The following are just some of the areas the Society help with:

Application Process - for Full Membership,

1. All applicants must complete and sign the membership application forms.
2. All applications for **Full Membership** must be accompanied by payment of £150.00 application fee (non-refundable).
3. All applications must be accompanied by details, photographs and description of work undertaken of at least 4 newly thatched properties completed in the last 2 years, including name and telephone number and email of the property owner. The property owner must have given permission and be aware that their property has been put forward for inspection.
4. All applicants must have carried out at least 25% of the work.
5. Sponsors of new applicants must be full members of at least two years - not associate or apprentice members. A sponsor will have to know the applicant and be confident that the applicant's work is of acceptable standard.
6. If an applicant is sponsored by a member of the executive committee, their work may not necessarily be inspected.
7. If the applicant is already a member of a local Master Thatchers Association, their work may not necessarily be inspected.
8. If the applicant has no sponsor, then two members must inspect the work - one must be an executive member. At least three properties will be inspected (preferably two finished re-thatches and one in progress).

Application Process - for Apprentice Membership, £25.00 per year

Apprentice membership is available to trainee thatchers enrolled on the NSMT Apprenticeship Scheme. Please discuss this with your employer, you will receive full details with your application to join the scheme.

Application Process - for Supporter of NSMT Membership, £35.00 per year

You can help support the craft of thatching by becoming a Friend of NSMT at a cost of £35.00 per year. You will receive our magazine, the Thatcher's Standard and be notified of events we become involved with. There may be discounts available to some events.

Guide to Considerate Site Practice

In order to keep a high level of respect of NSMT Ltd, members are asked to observe the following:

Consideration

Everyone affected by the project should be advised before work starts, neighbours etc. Nuisance caused by deliveries, traffic and parking should be minimised. Diversions should be clearly signed with special attention paid to the needs of those with sight, hearing and mobility difficulties.

Environment

Every effort should be made to reduce, reuse, and recycle waste. Materials should be obtained from sustainable sources, and local resources used where possible.

Appearance

The site should be doing all it can to create an image of which the industry can be proud. The site perimeter, the offices and all welfare facilities should be clean, tidy, and well presented. Waste, rubbish, and litter should not be allowed to accumulate. Dusty operations should be managed to minimise any inconvenience.

Good Neighbour

The site manager should interact proactively with residents and neighbours throughout the project to inform them about site activity and to pre-empt and avoid complaints. Any complaint should be logged and handled positively to achieve a satisfactory outcome for all concerned.

Respectful

Everyone on site should help to create a positive image and maintain respectable and safe standards of dress and behaviour. Improper conduct and language should be subject to disciplinary action.

Safety

Daily safety meetings must be held, and systems should be in place so that construction work is carried out with care and consideration for the safety of the public as well as for those living, visiting, and working on site. All persons must be vigilant and report any breach of Health and Safety to the responsible manager without delay. Scaffolding is a legal requirement in most situations. H&S policy, risk assessment and method statements should be carried out and recorded.

Materials

All materials must be stored and used in a manner to avoid the risk of deterioration before and during use.

Responsible

Considerate contractors should be aware of their obligations to personnel, act in a professional and conscientious manner, and play a part in the development of the industry's future workforce.

Accountable

Everyone associated with the site should understand and comply with the Site Code of Practice. The training and development needs for everyone on site should be identified and addressed.
